4 FIRST AID MEASURES

Remove victim to uncontaminated area wearing self contained breathing apparatus. Keep victim warm and rested. Call a doctor. Apply artificial respiration if breathing stopped.
Skin/eye contact In case of frostbite spray with water for at least 15 minutes. Apply a sterile dressing.
Immediately flush eyes thoroughly with water for at least 15 minutes.

6 ACCIDENTAL RELEASE MEASURES
